Saint Luke's Mid America Heart Institute opened its doors 40 years ago as the nation's first free-standing heart hospital. Today, we celebrate our ranking among the top programs in the region.

And we keep striving for more. Our cardiovascular experts performed numerous novel procedures in the last year alone, which included becoming the first in the region to perform a tricuspid valve replacement—a valve with limited treatment options. As of today, our valve program is the only program in the region to offer comprehensive valve disease care for all four valves, giving more hope to patients with complex heart issues.

Our team was also the first in the region to offer a new option for people with the most extreme form of peripheral artery disease for arteries below the knee. This new treatment option supports healing while reducing the risk of long-term complications.

In March, our team performed the first renal denervation in Missouri, which helps patients suffering from resistant hypertension and leads to safe and sustained reduction in blood pressure. These novel procedures would not have been possible without the help of our generous donors.

As a nonprofit, we rely on the support of our community to help further education, advance innovation, and continue providing exceptional care.
